



DIGinLaw Summer School

Maximum number of participants: 10

N. credits: 3: SIE and IPLE for "others formative activities" (art. 10 co. 5 lett. d. DM 270/2004); REL under "elective credits" (art. 10 co. 5 lett. a. DM 270/2004).

Access: The Summer School, which will take place in Zagreb, is open to undergraduate and graduate students enrolled in the universities of Aberdeen, Milan and Osijek (30 students in total). **10 excellent students** of Unimi will be selected by the Unimi selection committee on the basis of criteria indicated in the Call below. Interested students must submit their **statement of purpose, adequate evidence of the grades obtained in the study, and a CV**. Moreover, **very good command of English (level B2 or higher)**, both writing and speaking is required as the working language of the Summer School is English. Within the Project, funds are provided for each student to **cover the costs of travel and accommodation in Zagreb**.

How credits will be recognized: active participation to the five-day Summer school is mandatory. At the end of the Summer school, upon proof of the participation of students selected, the host University will release a digital badge and letter of attendance.

Training Objectives: While taking advantage of modern technologies at low environmental costs, the "Time to Become Digital in Law" (DIGinLaw) project raises awareness of digital demands in HE in law and fosters the creation of digital literacy and digital competence that is needed in the law labour market, thereby fostering free circulation of highly educated workers; and **creating open and inclusive society of legal knowledge and open access to scientific area dealing with effects of digitalization on law and legal education**. The goals of the DIGinLaw Summer School are: a) to present the **new developed methodologies** of courses for e-learning to the students of undergraduate and graduate students, and to b) encourage the mobility of the students who participate to the activity. The benefits of for students who participate to the Summer School are as follows: a) acquiring knowledge on the Digital Competences for Lifelong Learning for law students, b) acquiring **new knowledge on the digital technologies** and their possibility to integrate this knowledge to different fields of law, c) **international experience**, d) enhanced e-learning courses based on student's feedback becoming freely accessible online for further education.

Course organization: The University of Milan, partner to the "Time to Become Digital in Law" (DIGinLaw) project, funded by the Erasmus + Program, is participating to the Summer School organized by the University of Osijek (Coordinator of the project). The Summer school is organised as a **five-day event held in Zagreb, Croatia from 11 July to 15 July 2022**.

The Summer school is organized as part of the specific activities relating to the creation on open online resources in law by the development of **twelve high level Massive Open Online Courses (MOOCs)**. These MOOCs, are oriented towards the **digitization of legal education and law**, will be open and available not only to students of the three Faculties involved (starting in AY 2022/2023), but also for students worldwide. More specifically, the Summer School will focus on challenging topics corresponding to the developed MOOCs within the project. The first day of the Summer school (scheduled on 11 July 2022) is dedicated to an introductory lecture held by the University of Zagabria (UNIZG-SRCE) on **Digital Competences for Lifelong Learning for Law Students**. In the following days of the Summer School, teachers from three partner Universities (University of Milan, UNIMI; University of Osijek, UNIOS; and University of Aberdeen, UNIABD) will present selected aspects of their e-learning courses developed (MOOCs) in the framework of the project to 30 students (10 students selected by each University) in order to test the MOOCs. The attending students are invited to actively participate to the e-learning courses by performing the allocated tasks and case studies presented. They are then invited to give their evaluation and feedback on the courses in order to contribute to their further improvement. All courses are held in English, in facilities equipped with computers and audio-video equipment. It is recommended that all students provide their own laptop or tablet. Conditions of participation

The University of Milan – UNIMI, within the Project “Time to Become Digital in Law (DIGinLaw)”, is selecting **10 excellent students** to participate to the DIGinLaw Summer school, which will be held in **Zagreb, Croatia**, from **11 July to 15 July 2022**. The Summer School is open to undergraduate and graduate students enrolled in the universities of Aberdeen, Milan, and Osijek (10 students from each university).

In general, the Summer School is thematically oriented towards the digitization of legal education and law, and challenging topics corresponding to the developed MOOCs within the DIGinLaw project will be considered. The Summer school is organized as part of the specific activities relating to the creation on open online resources in law by the development of twelve high level Massive Open Online Courses (MOOCs). These MOOCs, are oriented towards the digitization of legal education and law, will be open and available not only to students of the three Faculties involved (starting in AY 2022/2023), but also for students worldwide. Application procedure

Applicants must fill the form available at this [link](#) and upload the necessary documentation where required in the form. Documents required are the following:

- a) **a cover letter** (max. 1 page), stating the **motivation** for their application (in English);
- b) transcript of **academic career**, with the grades obtained in all the exams taken (screenshot of the relevant UNIMIA page- pdf/jpeg);
- c) an **up-to-date curriculum vitae**, possibly in Europass format, with an indication of the university and degree of enrolment;
- d) **proof of English proficiency at level B2 or higher, if available.**

The incomplete applications will not be considered.

Application deadline

All the documents required must be **sent by using the form indicated** (<https://forms.office.com/r/UWhBB7nKOK>, access with Unimi credentials) by **19 May 2022** under penalty of exclusion from the selection.

Selection procedure

The applications will be assessed by a selection committee, composed by Prof. Francesca Clara Villata, Prof. Alessandra Lang, and Prof. Jacopo Re. The committee shall evaluate and rank the applicants according to their merit.

For each candidate, the overall score will be obtained by summing up the following partial scores:

1. Statement of purpose (up to 30/100);
2. Academic career (30/100)
3. CV (up to 20/100);
4. Proficiency in English (up to 20/100).

The minimum threshold to participate to the Summer school is 60/100. Only candidates achieving an overall score of at least 60/100 will qualify for the selection.

Selection results

Upon completion of the selection procedures by the selecting committee, applicants will **receive communication on the email address they indicated** in the form when applying by 20 May 2022. The **selected students** will be required to **purchase their flight tickets** to Zagreb autonomously (which will be subsequently reimbursed, see "Grants and benefits" below) to participate to the Summer School under penalty of losing their place in the Summer School.

In order to confirm the reservation of their place in the Summer school, students must provide proof of purchase of flight tickets to attend the conference in the dates scheduled, by sending the flight ticket to Giulia Gabrielli (giulia.gabrielli@unimi.it) by **25 May 2022**.

Proof of purchase of plane tickets is mandatory in order to be allowed to participate to the Summer School. The selected students who fail to provide such proof will lose their place in the Summer School in favor of the next best applicant.

Grants and benefits

Within the Project, funds are provided for each selected student to cover the costs of **travel to and from Zagreb and accommodation in Zagreb** (6 nights, breakfast and dinner) upon presentation of boarding passes and letter of participation to the Summer school. Each student is obliged to be present in Zagreb from 10 July 2022 to 16 July 2022. The accommodation in Zagreb (6 nights), as well as meals during the event will be arranged by the hosting University. Selected students will be accommodated in double rooms. Conversely, as provided under section "Selection procedure", **selected students must purchase their tickets autonomously by 25 May 2022**. Each student will have a maximum budget of **€250** to cover the expenses of the flight tickets to and from Zagreb. In case for any reason the student does not participate to the Summer School, no refund to cover the price of flight tickets will be issued (purchase of a flight insurance is suggested). The students will receive the refund of the cost of the tickets after the Summer School, upon presentation of the **boarding pass** of each flight, and the **letter of participation** to the Summer School issued by the hosting University. The exact modality of the payment of the travel expenses will be communicated to the selected students.

Final assessment

In order for the 3 credits to be awarded, students who participated to the Summer School will be required to answer self-reflection questions on the learning outcomes upon their return.
